## MARKHAM FUNERAL SERVICE: PAYMENT TERMS

### Unattended Direct Cremation:

We require the full balance of the Funeral Account 72 hours prior to Funeral Date.

### Attended Funeral Service:

A deposit amount of 50% of the full Funeral Account that is shown on our estimate of costs on the back of the arrangement form that is signed upon arrangement of a funeral is required 72 hours prior to Funeral Date as stated in our Terms and Conditions of Business. (Full Pro Forma Invoices can be produced upon request)

A full invoice amount will be produced and sent seven days after the Funeral Service has taken place. Accounts are then due for settlement in full, 14 days from invoice date as stated in our Terms and Conditions of Business.

### Late Payment Terms:

If the Client fails to make a payment due to the Supplier under the Contract by the due date, the Client shall pay interest on the overdue sum from the due date until payment of the overdue sum, whether before or after judgment at the rate of 4% a year above the Bank of England's base rate from time to time, but at 4% a year for any period when that base rate is below 0%. All amounts due under the Contract shall be paid in full without any set-off, counterclaim, deduction or withholding. A full copy of our Terms and Conditions of Business will be provided upon arrangement of a Funeral however a copy may be requested at any time prior to arrangement and will be supplied.
